# **Section 4 - First Aid Measures**

# 4.1 Description of first aid measures

#### Inhalation

Remove source(s) of contamination and move victim to fresh air. If breathing has stopped, give artificial respiration, then oxygen if needed. Contact physician immediately.

#### **Eye Contact**

Flush eyes with plenty of water. If irritation persists, seek medical attention.

#### **Skin Contact**

In case of skin contact, wash thoroughly with soap and water.

#### Ingestion

Do not induce vomiting unless instructed by a physician. Never give anything by mouth to an unconscious person.

# 4.2 Most important symptoms and effects, both acute and delayed

#### General

Irritation to eyes, skin and respiratory tract. Causes serious eye damage.

#### Inhalation

Breathing dust may cause nose, throat, or lung irritation, including choking, depending on the degree of exposure. Prolonged or repeated inhalation of respirable crystalline silica from this product can cause silicosis, a seriously disabling and fatal lung disease. Some studies show that exposure to respirable crystalline silica may be associated with increased incidences of autoimmune disorders such as scleroderma, systemic lupus erythematosus, rheumatoid arthritis, and diseases affecting the kidneys. The extent and severity of lung injury depends on duration and level of exposure. Corrosive to the respiratory tract.

#### **Skin Contact**

Slag may cause dry skin, discomfort, irritation, and dermatitis. Slag can cause dermatitis by irritation and allergy. Skin affected by dermatitis may include symptoms such as, redness, itching, rash, scaling, and cracking. Irritant dermatitis is caused by the physical properties of slag including moisture and abrasion. Allergic contact dermatitis is caused by sensitization to hexavalent chromium (chromate) present in slag. The reaction can range from a mild rash to severe skin ulcers. Persons already sensitized may react to the first contact with slag. Others may develop allergic dermatitis after years of repeated contact with slag.

# **Eye Contact**

Airborne dust may cause immediate or delayed irritation or inflammation. Eye contact with copious amounts of dry powder or with wet slag can cause moderate eye irritation. Eye exposures require immediate first aid to prevent considerable damage to the eye.

# Ingestion

Do not ingest slag. Ingestion is likely to be harmful or have adverse effects.

**Chronic Symptoms:** If dust is generated, repeated exposure through inhalation may cause cancer or lung disease.

# 5.3 Advice for firefighters

Use water spray to cool fire-exposed surfaces and to protect personnel. Shut off "fuel" to fire. If a leak or spill has not ignited, use water spray to disperse the vapors. Either allow fire to burn under controlled conditions or extinguish with foam or dry chemical. Try to cover liquid spills with foam. Because fire may produce toxic thermal decomposition products, wear a self-contained breathing apparatus (SCBA) with a full-face piece operated in pressure demand or positive-pressure mode.

#### **Section 6 - Accidental Release Measures**

# 6.1 Personal precautions, protective equipment and emergency procedures

Only properly protected personnel should remain in the spill area; dike and contain spill. Stop or reduce discharge if it can be done safely.

#### 6.2 Environmental precautions

Stop spill/release if it can be done safely. Prevent spilled material from entering sewers, storm drains or unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers. No special environmental precautions required.

# 6.3 Methods and material for containment and cleaning up

Put on appropriate protective gear including NIOSH/MSHA approved self-contained breathing apparatus, rubber boots and heavy rubber gloves. Dike and contain spill; absorb or scrape up excess into suitable container for disposal; wash area with dilute ammonia solution. Stop or reduce discharge if it can be done safely. Follow applicable OSHA regulations (29 CFR 1910.120) for disposal.

# 7.1 Precautions for safe handling

Keep container(s) tightly closed and properly labeled. Store in cool, dry, well ventilated place away from heat, direct sunlight, strong oxidizers and any incompatibles. Store in approved containers and protect against physical damage. Keep containers securely sealed when not in use. Indoor storage should meet local standards and appropriate fire codes. Containers that have been opened must be carefully resealed to prevent leakage. Empty containers retain residue and may be dangerous. Avoid water contamination.
