**Inhalation**

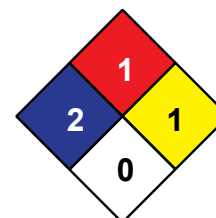

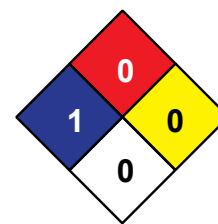
