#### Inhalation

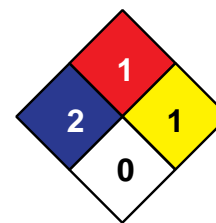

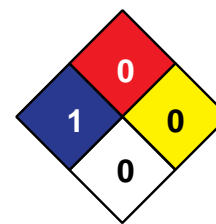
