Inhalation

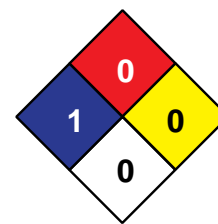

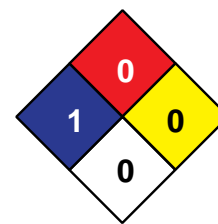
